Looking Back on 2021

Wow! What a year it has been. After three years of migrating agency by agency, Office 365 Phase I and Phase II onboarding for all State Agencies was completed in September, in addition to the Statewide Public Folder migration. On October 25th, Skype for Business was formally retired for State employees. In December, the migration of SharePoint 2010 to SharePoint Online was completed, and throughout the year, several new services were introduced:

- · Teams Live Events
- Shift App
- Forms App
- Archive Mailbox Services

In November, the MyHub Governance app was introduced to the Department of Technology and Information (DTI). DTI will pilot the app, then will begin deployment to other agencies in the 1st Quarter 2022.

Let's Talk About Governance...

A new governance service is coming to Microsoft Teams. It is called "MyHub US Gov", a.k.a. MyHub. MyHub is one service of AvePoint Online Service (AOS) cloud governance suite currently being piloted within the Department of Technology and Information.

MyHub will help automate governance of Teams accounts by providing inactivity review, membership review, ensuring two-owner requirement, and Teams name enforcement (i.e., consistently begin with an agency acronym to easily identify ownership). MyHub will also provide a workflow and an approval process to archive, delete, change contacts, and restore an Archived Teams workspace. Additionally, for users with authority to request a new Teams workspace, the request workflow will move from a ServiceNow service catalog item to a request process within the MyHub app.

Beginning in Q1 of 2022, the MyHub app will be deployed/enabled in an agency by agency strategy, similar to how Phase I and Phase II were.
